

Ms. No.54, Home(Ser.I) Department, dated 22.2.2014 and G.O. Ms. No.115, Home(Ser.I) Department, dated 18.7.2014, subject to outcome of any other O.As/W.Ps/pending before the Hon'ble APAT/High Court and subject to condition that the notional seniority ordered shall be on the principle of " no work no pay" and for the purpose of seniority and promotion only and not for other financial benefits.


